Dear Conference Participants,

The Academic Department of History and Theory of Education at the Faculty of Education, University of Bialystok, plans to hold a series of conferences titled "Children in History." In 2024, as part of this series and in commemoration of the 1000th anniversary of the first Polish coronation, the department aims to reflect on the education of children, considering the aspects of dignity and restrictions from the era of Bolesław Chrobry to the present day. We intend to refer to Polish educational traditions, which - we hopewill be an inspiration to discuss the past, present and future of the children, considering their needs and socio-cultural changes. We believe that a review of Polish traditions in the field of subjective treatment of children is desirable, especially in the era of transformation of European social structures and developing neoliberalism. Referring to the centuries-old experience of Polish pedagogy is an effective way of shaping one's own identity.

We propose that papers and discussions focus on the child's needs in terms of:

- 1. Individual (evolution of education over 1000 years of Polish history, individual needs and capabilities of the child, psychosocial development of the child, impact of the natural environment, impact of cultural and social values, children's rights).
- 2. Institutional (activities of schools and educational institutions, including institutions for children with individual developmental and educational needs, methods and forms of education, educational challenges and the face of social changes, health education, forms of child care).
- 3. Social (the role of the child in society, pedagogical concepts, development of the theory of education, educational traditions, the child as a subject in philosophical, anthropological, sociological, philological and psychological thought; Polish perspective in the global context considering the Polish educational experience in the context of global trends and comparing it with the practices of other cultures and nations).

The topics provided are indicative and do not diminish the inventiveness and ingenuity of the participants of the meeting in any way. We hope that scientists and experts from social sciences, humanities and medicine will take part in it. We plan to organize a two-day debate of representatives of various scientific disciplines: pedagogy, psychology, history, law, sociology, political science, theology, philosophy, medicine, biology and other experts interested in the indicated issues, which will allow for a multi-faceted and comprehensive approach to the analyzed issues. We anticipate the participation of scientists affiliated with foreign research units, including those from: England, Bulgaria, Belgium, Italy, Lithuania, Ukraine.



SUBMISSION OF PAPERS

The cost of the conference is PLN 380 (PLN 280 for students and PhD students).
